Outlook 2023

The development of the global economy is still subject to great uncertainty. Momentum in global industrial and chemical production remained subdued. The outlook and the assumptions regarding the global economic environment as presented in the BASF Report 2022 continue to apply:

- Sales: €84 billion – €87 billion
- EBIT before special items: €4.8 billion – €5.4 billion
- Return on capital employed (ROCE): 7.2% – 8.0%
- CO₂ emissions: 18.1 million metric tons – 19.1 million metric tons
- Growth in gross domestic product: 1.6%
- Growth in industrial production: 1.8%
- Growth in chemical production: 2.0%
- Average euro/dollar exchange rate: \$1.05 per euro
- Average annual oil price (Brent crude): \$90 per barrel

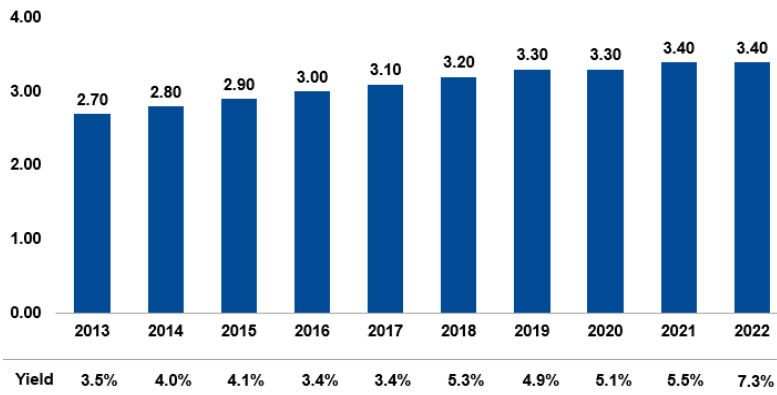

Shareholder structure

With over 900,000 shareholders, BASF is one of the largest publicly owned companies with a high free float. An analysis of the shareholder structure carried out at the end of March 2023 showed that, at around 18% of share capital, the United States and Canada made up the largest regional group of institutional investors. Institutional investors from Germany accounted for around 6%. Institutional investors from the United Kingdom and Ireland hold 7% of BASF shares, while investors from the rest of Europe hold a further 11% of capital. Institutional investors from the rest of the world, including the Asia Pacific region, hold 3% of BASF shares. Approximately 45% of the company's share capital is held by private investors, nearly all of whom reside in Germany. BASF is therefore one of the DAX companies with the largest percentage of private shareholders.
