Share buyback – 24th Interim Report

Ludwigshafen – June 27, 2022 – In the period from June 20, 2022 until and including June 24, 2022 a number of 1,026,647 shares were bought back within the framework of the share buyback program of BASF SE; on January 11, 2022, BASF SE disclosed pursuant to art. 5 para. 1 lit. a) of the Regulation (EU) no. 596/2014 and art. 2 para. 1 of the Delegated Regulation (EU) no. 2016/1052 the start of the share buyback on January 11, 2022.

The total volume of shares which have been bought back within the framework of the share buyback program in the period from January 11, 2022 until and including June 24, 2022 amounts to a number of 18,495,079 shares.
