**Application**

ACROFLOR 10 is designed for application into floor finishes for black heel mark resistance improvement, scuff and mar resistance, and coefficient of friction modification. Formulations can be made, dependent on resin, for balance of burnishability with low-maintenance properties.

Typical loadings in a floor finish are between 4-15% wax solids on total solids. Loading level should be evaluated per application based on desired performance.

Formulations can be optimized for a variety of flooring substrates such as vinyl, vinyl composite, terrazzo, and concrete and quarry tile.
