Share buyback – 11th Interim Report

Ludwigshafen – March 28, 2022 – In the period from March 21, 2022 until and including March 25, 2022 a number of 466,771 shares were bought back within the framework of the share buyback program of BASF SE; on January 11, 2022, BASF SE disclosed pursuant to art. 5 para. 1 lit. a) of the Regulation (EU) no. 596/2014 and art. 2 para. 1 of the Delegated Regulation (EU) no. 2016/1052 the start of the share buyback on January 11, 2022.

The total volume of shares which have been bought back within the framework of the share buyback program in the period from January 11, 2022 until and including March 25, 2022 amounts to a number of 13,092,513 shares.
