

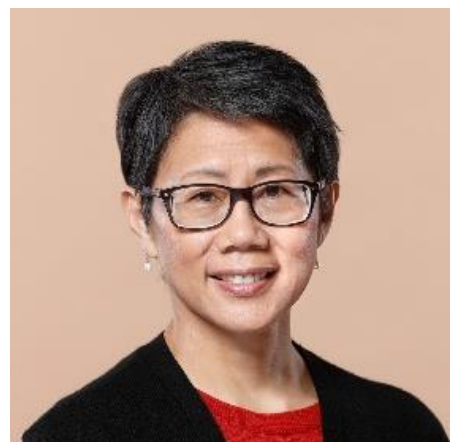
The BASF Stakeholder Advisory Council Members

The Stakeholder Advisory Council consists of various renowned thinkers and leaders, whose knowledge and experience on material sustainability topics bring in an important external perspective. It meets annually with the members of BASF's Board of Executive Directors to critically evaluate and refine the sustainability management of BASF on the basis of a shared dialogue. Advisory Council Members act in personal capacity and do not represent their organizations.

Ralf Fücks is the founder and Director of The Center for Liberal Modernity, a starting think tank based in Berlin. From 1996 to 2017, he was President of the Heinrich-Böll-Foundation, a German think tank and international policy network, with focus on sustainable development and green growth, welfare state, migration, the future of Europe, and foreign policy. He served as a Deputy Mayor for Urban Development and Environmental Protection in the City State of Bremen. Ralf Fücks contributes regularly to national and international media, including his books *Green Growth, Smart Growth* (2014) and *Defending Freedom* (2017).



Dr Christine Loh, SBS, OBE, JP, is Chief Development Strategist at the Institute for the Environment at Hong Kong University of Science and Technology. She is a Director and Trustee of CDP Worldwide, as well as a Director of the Global Maritime Forum. Dr Christine Loh was Under Secretary for Environment in the HKSAR Government and a former legislator. She has established several NGOs in the environment and urban planning area, as well as having been the CEO of an independent public policy think tank. Dr Loh, a lawyer by training, had a 14-year career in physical commodities trading, and was an elected member of the Hong Kong stock and futures exchange. She is a published author and Chevalier de l'Ordre National du Mérite.



Timothy James Mohin is a partner and director for the Boston Consulting Group (BCG) in climate and sustainability. Prior to BCG, Tim was the Chief Sustainability Officer with leading carbon accounting software company – Persefoni. He is the former Chief Executive of the Global Reporting Initiative (GRI), the world’s largest sustainability reporting standard. In 2021, he was Senior Director of Corporate Responsibility for Advanced Micro Devices as well as Chairman of the Board of the Responsible Business Alliance (formerly EICC). Tim Mohin has established corporate responsibility and sustainability strategies as Director of Sustainable Development at Intel Corporation and as head of Apple’s Supplier Responsibility Program. While working for the U.S. Government, he led the development of toxics regulation of the Clean Air Act Amendments at EPA. He also served as senior legislative staff for the Chairman of Senate Committee on Environment and Public Works. Tim Mohin wrote the book “Changing Business from the Inside Out” (2012).



Fiona Reynolds, currently chair of the United Nations Global Compact Network Australia, was the CEO of Conexus Financial. She served as the CEO of the Principles for Responsible Investment (PRI) for over nine years, stepping down at the beginning of 2022. Fiona has 25 years' experience in the financial services and pension sector. She joined the PRI from the Australian Institute of Superannuation Trustees (AIST), where she spent seven years as CEO. Fiona was named one of the 20 most influential people in sustainability globally by Barron’s magazine and has twice been named one of Australia’s one hundred women of influence by the Australian Financial Review. Fiona also serves on the Board of Frontier Investment Consulting, the investment Committee of the Laudes Foundation and Advisory Boards of Quinbrook Infrastructure Partners, PWC, and Affirmative Investment Management.



Dr Stephan Singer is Senior Advisor of Climate Science and Global Energy Policies at the Climate Action Network International (CAN), comprising about 1800 CSO in about 130 nations. Before joining CAN in 2016, Dr Stephan Singer worked for 22 years at WWF, among others as Director International Energy Policy. He is engaged with various civil society and academic organizations on the phase-out of fossil fuels and is a regularly invited peer reviewer of the IEA World Energy Outlook and for the IPCC where he leads the global CAN input. He is member of the newly formed Advisory Committee of REN21, an intergovernmental global organization for promotion of renewables and sustainability of renewable energies and of the Advisory Board of “NEGEM”, a EU-funded research consortium that seeks sustainable options for “negative emissions”.



Professor Youba Sokona is Second Vice-President of Groupe de Réflexion, d'Analyses et d'Initiatives Novatrices (GRAIN), while also being the elected Vice-Chair of the Intergovernmental Panel on Climate Change (IPCC) since 2015. Previously, he was Senior Advisor for Sustainable Development at the South Centre, an intergovernmental organization of 54 developing countries. Professor Sokona is Special Advisor to the African Energy Leaders Group of the Sustainable Energy for All initiative. He is Member of the African Academy of Sciences as well as Member of the Science Advisory Committee of the International Institute for Applied System Analysis (IIASA). Youba Sokona is also part of the Advisory Board of the Payne Institute for Public Policy of the Colorado School of Mines, USA. He previously coordinated the African Climate Policy Centre of the UN Economic Commission for Africa. Professor Sokona holds a PhD in Engineering and Earth Sciences and is an honorary professor at University College London (UCL).
