**Re: Intimation under Regulation 30 of Securities Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (“SEBI Listing Regulations”)**

We refer to our earlier letter dated 6<sup>th</sup> October 2023, wherein the Company had informed regarding the receipt of a Show Cause Notice (SCN) dated 30<sup>th</sup> September 2023 pertaining to FY 2017-18 from the Deputy Commissioner of State Tax, Mumbai, Maharashtra raising a total demand of INR 282,58,06,878/- (i.e. tax, interest and penalty) mainly with regard to transitional credit claimed by the Company in Form Tran-1 and mismatch of Input tax credit (ITC) with GSTR-2A records, under the relevant provisions of the Central Goods and Services Tax Act, 2017, Maharashtra Goods and Services Tax Act 2017 and Integrated Goods and Service Tax Act, 2017.

As the above said SCN was received by the Company pursuant to the GST audit conducted for the FY 2017-18, we now wish to inform you that the Deputy Commissioner of State Tax, Mumbai vide Demand order dated 29<sup>th</sup> December 2023 has dropped the proposed demand relating to transitional credit claimed by the Company in Form Tran-1 in entirety and in respect of other matters, partial relief has been granted.

Accordingly, the demand of INR 282,58,06,878/- (i.e. tax, interest and penalty) has now been reduced to INR 14,21,30,504 (i.e. tax, interest and penalty). The details of the same are as under: -
