# BASF and RBTS signed Memorandum of Understanding to jointly develop new opportunities in automotive refinish market

Shanghai, China - December 2, 2024 - BASF (China) Co., Ltd. (hereinafter referred to as "BASF") and Bosch Automotive Technology Service (Beijing) Co., Ltd. (hereinafter referred to as "RBTS") jointly signed a memorandum of understanding at Automechanika Shanghai to collaborate on the automotive aftermarket business.
