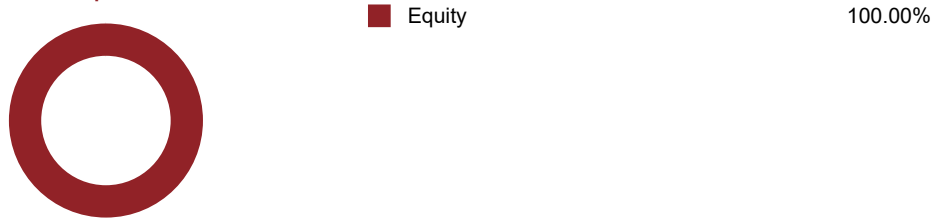
The main factors which may increase the risk of this fund include:

- Any concentration in specific areas or sectors

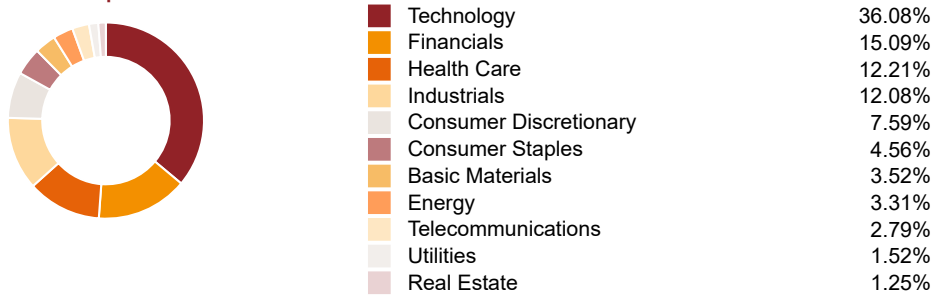
