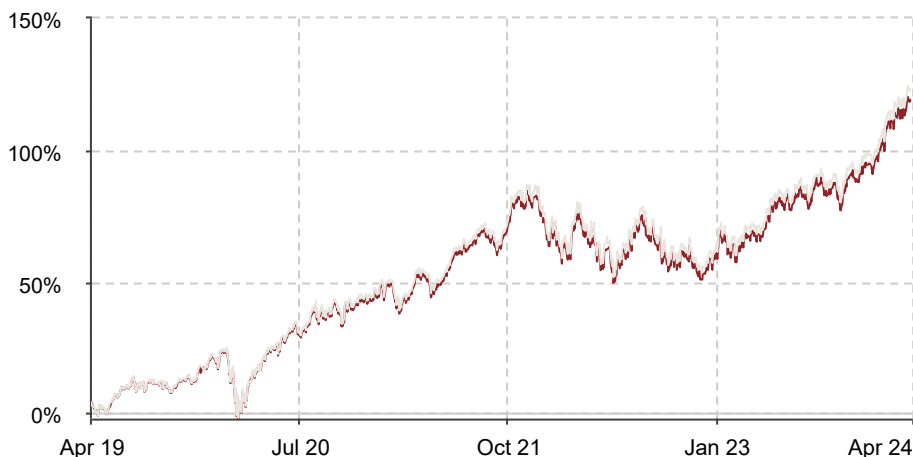

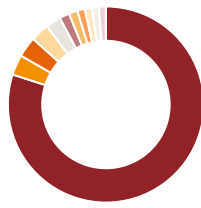
The main factors which may increase the risk of this fund include:

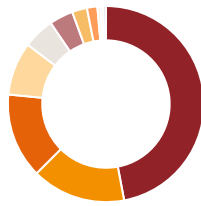
