**Share buyback – 28th Interim Report / Correction**

In the period from July 18, 2022 until and including July 22, 2022 a number of 199,952 shares were bought back within the framework of the share buyback program of BASF SE; on January 11, 2022, BASF SE disclosed pursuant to art. 5 para. 1 lit. a) of the Regulation (EU) no. 596/2014 and art. 2 para. 1 of the Delegated Regulation (EU) no. 2016/1052 the start of the share buyback on January 11, 2022.

The number of shares bought back daily and the daily volume-weighted average share prices are as follows:

The total volume of shares which have been bought back within the framework of the share buyback program in the period from January 11, 2022 until and including July 22, 2022 amounts to a number of **20,280,652** shares.

The purchase of the shares of BASF SE is carried out by a bank that has been commissioned by BASF SE; the shares are purchased on the electronic trading platform of the Frankfurt Stock Exchange (Xetra).
